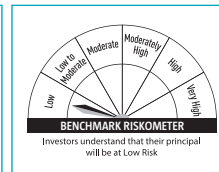
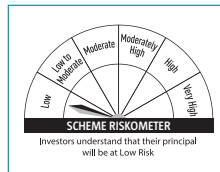


## CANARA ROBECO OVERNIGHT FUND

Overnight Funds are open ended debt schemes which invest in securities with a maturity of 1 business day. Without exposing investors to a lot of risk, such funds have relatively lower interest rate risk and with higher liquidity.

### Presenting Canara Robeco Overnight Fund

Canara Robeco Overnight Fund is an open-ended debt scheme investing in overnight securities with a maturity 1 business day. The scheme intends to invest its assets in overnight securities to generate returns corresponding to the overnight rates in the market. The scheme seeks to generate returns commensurate with low risk and providing high level of liquidity, through investments made primarily in overnight securities.

Investments under Canara Robeco Overnight fund would be made predominantly in tri-party repos, overnight reverse repos and fixed income securities/instruments with overnight maturity. It is an attractive opportunity for corporate and individual investors who wish to park their idle funds for a very short period of time.

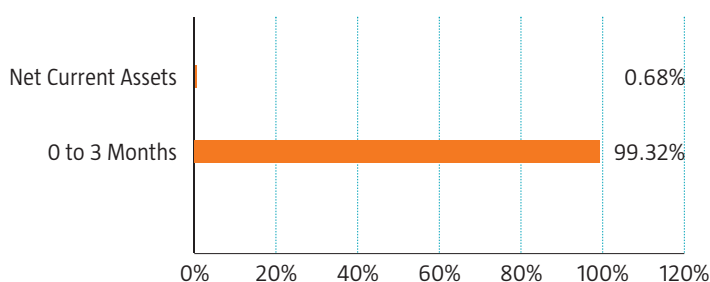
