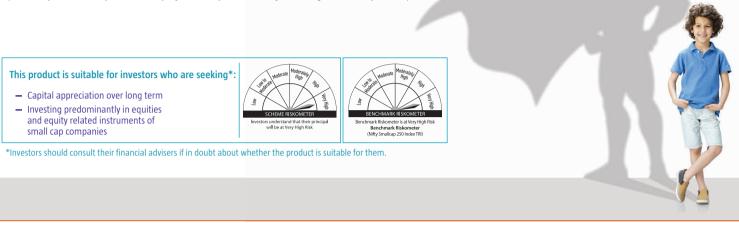

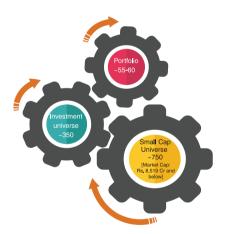
# **CANARA ROBECO SMALL CAP FUND**

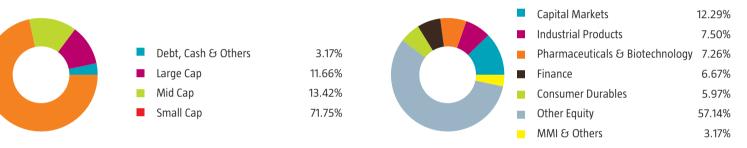
MARKET CAPITALIZATION (as on 31st October, 2024)
