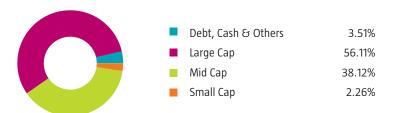

# MARKET CAPITALIZATION (as on 31st March, 2021)

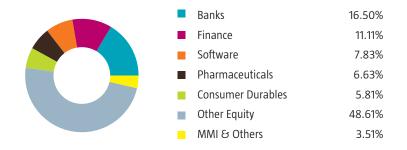
